

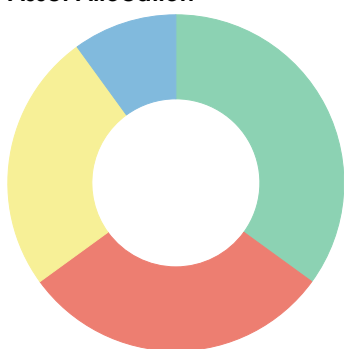
# NVEST STABLE PORTFOLIO

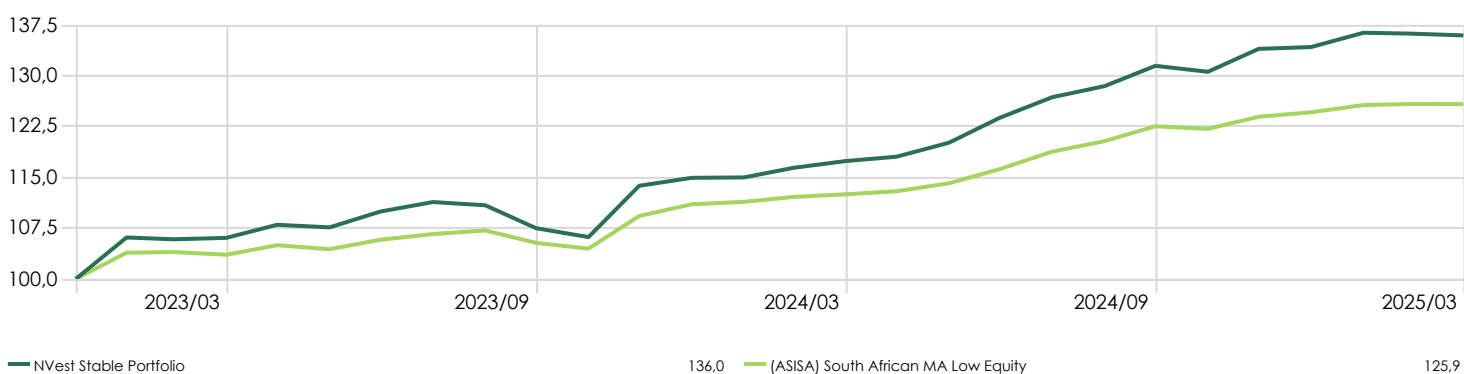
