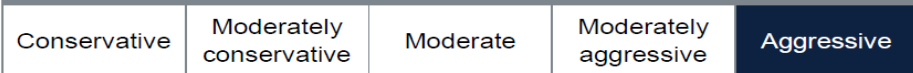
## Investor Profile

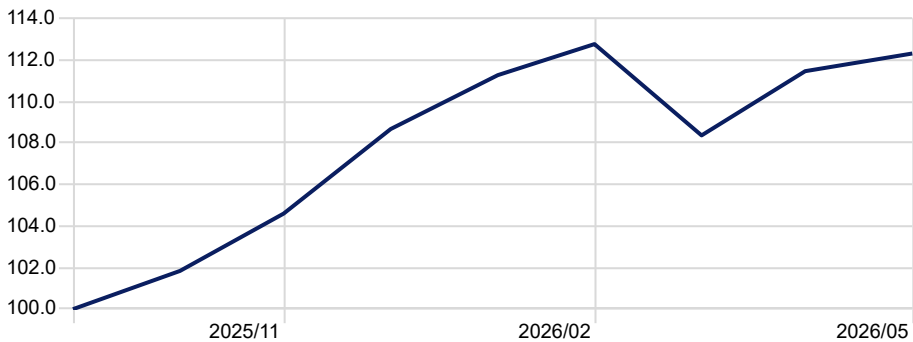

Time Period: Since Common Inception (2025/10/01) to 2026/05/31



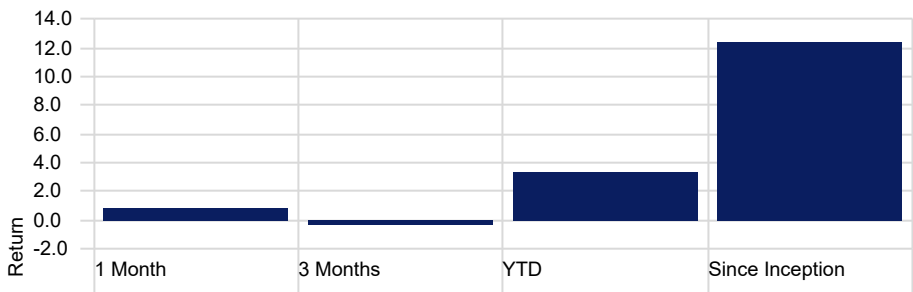

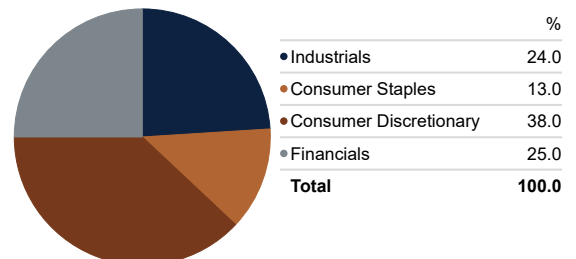
