

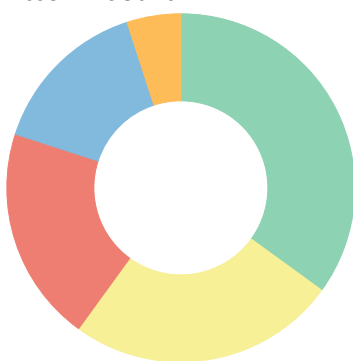
NVEST STABLE PORTFOLIO

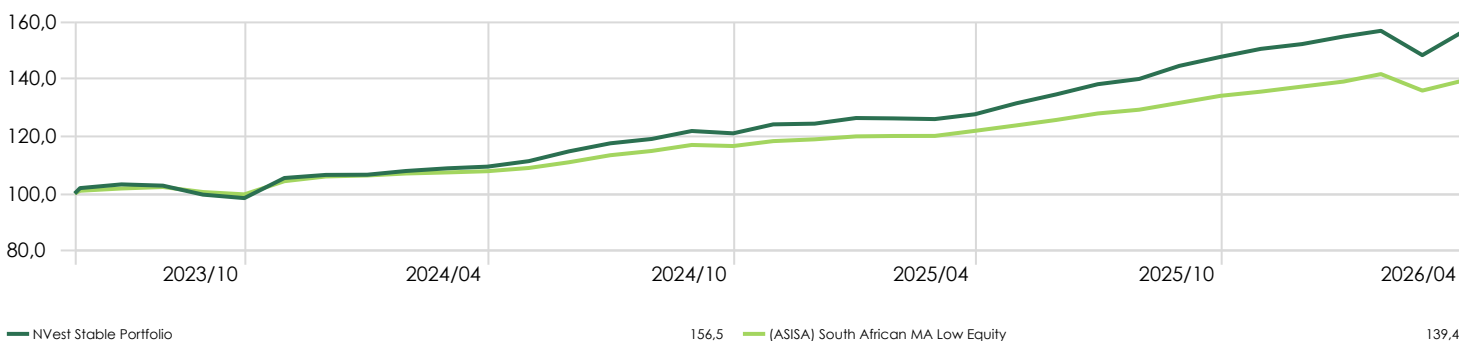
